EXHIBITOR CONTRACT

Please describe your product/service in the space provided (**must be completed**):

IT IS MUTUALLY AGREED BETWEEN The Lakelands Association of REALTORS®, (LAR) the licensee, and the Exhibitor herein that:

1. LAR grants the Exhibitor the privilege to use space identified as exhibit tables at Casino Rama during the Trade Show subject to the Rules & Regulations of LAR and Casino Rama, which form a part of this Agreement between LAR and the Exhibitor.
2. Exhibit table space is sold in 6 ft tables on a first come-first served basis. Only a certain number of each business category will be accepted as space is limited. LAR holds the right to refuse applicants. The Trade Show will open for set up at 10:30 a.m. and close at 3:00 p.m. with Door prize draws following.
3. This agreement is not subject to cancellation by the Exhibitor. In the event, however, that the Exhibitor cannot mount a display in the exhibit area, the Exhibitor has the right to assign its contract to another Exhibitor upon approval in writing from LAR subject to all terms and conditions as set out in this agreement.
4. Final allocation of exhibit space shall be at the sole and absolute discretion of LAR. If LAR decides that re-location of an Exhibitor is necessary to provide a balanced ambience in the exhibit area, then the Exhibitor shall abide by the decision of LAR.
5. The Exhibitor will confine their exhibit to their exhibit table space(s).
6. **Exhibitor set up time is between the hours of 10:30a.m. and 11:30a.m.** The Exhibitor will have their exhibit space set up prior to the opening of the trade show **and will remain open until 3:00 p.m.**, which is closing time.
7. The Exhibitor hereby remises, releases and forever discharges LAR of and from any liability resulting from the death of or personal injury to the Exhibitor, any of its employees or any person visiting the exhibit area and from damages to the property of the Exhibitor or any such person which death, injury or damage, as the case may be, is caused directly or indirectly by any act or omission of the Exhibitor. The Exhibitor hereby indemnifies and saves harmless LAR of and from any loss, cost, damage or expenses incurred by LAR as a result of any such death and/or injury to such person or damage to property however caused.
8. The Exhibitor acknowledges that Casino Rama is not to be held responsible for loss of or damage to exhibits or other property for the purpose of your exhibition, and the Exhibitor will accept responsibility for any damage caused by your exhibits and will indemnify and save harmless Casino Rama from and against any loss or damage no matter how caused.

The Exhibitor hereby indemnifies and saves harmless LAR of and from any loss, cost, damage or expenses incurred by LAR in connection with non-compliance by the Exhibitor with this agreement and any such rules and regulations and in connection with any obligation undertaken by the Exhibitor thereunder.
